

LMAP Youth Ministry Behaviour Expectations and Responsibilities

The aim of these expectations are to be clear on what is asked of the youth, leaders and parents/guardians when involved in any LMAP Youth ministry.

Lower Mountains Anglican gathers to proclaim Christ (Col 1:28) and so our Youth Ministry is geared to make this aim possible in partnership with youth, leaders and parents/guardians.

These 'LMAP Youth Ministry Behaviour Expectations and Responsibilities' apply for youth in the equivalent of school years 7 to 11 - those attending Friday Youth and associated activities. In the case of Crossfire (which covers school age 6-8), the 'LMAP Kids Ministry Behaviour Expectations and Responsibilities' apply as it is a Sunday Gathering ministry.

- There may be reasons when a **youth person** finds these behaviour expectations difficult which may result in the development of a Pastoral Care Plan to assist them, leaders and parents in working together for the benefit of both the youth person and the wider needs of the ministry in question.
- There may be incidents where the LMAP leader does not follow the expectations outlined here in which case further training, correction or
 perhaps removal from leadership might be necessary. We are mindful that LMAP Leaders are volunteers and although safe ministry trained,
 may not be professionally equipped to handle high needs situations.
- There may be incidents where that **Parent/s/Guardian** do not support these behaviour expectations or can not see their son/daughter abiding by what is asked in which case the parent will be asked not to involve their son/daughter in LMAP Youth Ministry.



LMAP Youth Ministry Behaviour Expectations and Responsibilities

These expectations apply for youth from Year 7 to 11 school level. In the case of Crossfire (which covers school age 6-8), the Kid's Ministry guidelines apply.

To ensure children are ticked present and leaders present are recorded. 	 To register their son/daughter (one-off - link from Website per ministry) To keep their child away from the Youth Ministry programs if the youth person is sick. Transport (or arrange transport) of their son/daughter and ensure they are checked in to the Youth Program. Be on time both for drop-off and pick-up. To inform leaders if there is any pressing concern (external/internal) which may be impacting the youth person. (e.g. home/ school/ medication/ grief/ AVO etc.) Note: if parents need to have access to their son/daughter during a youth program, they can contact the on-Point leader (given the youth should not have their phones active).

LMAP Youth Ministry Behaviour Expectations and Responsibilities

These expectations apply for youth from Year 7 to 11 school level. In the case of Crossfire (which covers school age 6-8), the Kid's Ministry guidelines apply.

RED	Keep the youth safe With point person, contact Personal Quardian to core/remove the	 Come immediately to their son/daughter and the Leaders assistance – remove the youth.
- High Alert e.g. Deregulation of youth/ Incident/ Accident	Parents/guardian to care/remove the youth. Following: Incident Report Provide Incident Report to LMAP Safe Ministry Officer With Min Team Rep Follow-up of youth/parents Follow-up of other youth who may have been affected Pastoral Care plan to be developed or reviewed (with Min Team Rep/Parents/Key Leaders) before the youth re-enters the ministry group. Pastoral Care Plan to be reviewed by LMAP Safe Ministry Officer.	Keep youth away from the ministry until a Pastoral Care Plan can be developed/ reviewed. (i.e. CREEN/VELLOW/RED)

Note: An incident Report is required if there is any injury or accident regardless of the 'level of concern' (i.e. GREEN/YELLOW/RED)

Pastoral Care Plan

The Aim of a Pastoral Care plan is to support the needs of each child/youth (with particular reference to the person who needs support) whilst balancing the needs of the ministry group at large.

It provides agreed upon values and recommendations to help manage incidents which may arise to keep both the youth person/s and leaders safe.

In developing the Pastoral Care Plan, it takes what is are the established *LMAP Youth Ministry Behaviours and Expectations* (above) which is applicable for all youth/leaders/parents in the LMAP programs, and it adds particular recommendations for the youth person in question. In this way, particular and specific recommendations can be made that may support the unique needs of the youth person for whom the plan is developed.
